Boys Sections 1 to 10 inclusive play one doubles, 6 game set, tiebreak at 6-all. Boys Sections 11 - 15 inclusive play one doubles, straight 6 game set.

Girls Section 1 - 5 inclusive play one doubles, 6 game set, tiebreak at 6-all. Girls Section 6 - 9 inclusive play one doubles, straight 6 game set.

To be eligible to play in the finals, players must have played at least 4 matches during the current season with 3 matches played prior to the last three matches, with that team, or a lower graded team in their Club.
